Assembly

- 1. Fold in bottom flaps and seal center seam with one (1) strip of 3M #375,48mm wide, clear tape. Extend beyond each edge by at least 2". (Figure 1)
- 2. Place anti-static bag in box. (Figure 2)
- 3. Do not completely fill inner container with liquid. Allow sufficient ullage for liquid expansion. Tighten cap to specifications (in the above chart).
- 4. Secure the bung fitting to specifications (in the above chart).
- 5. Place the container in an upright position in box (Figure 3).
- 6. Fold top of bag to cover top of can completely. Figure 3).
- 7. Close top flaps of box and seal center seam as described above in line one. (Figure 4).
- 8. Mark and label each package in accordance with the appropriate regulations. At least one (1) set of UN markings and two (2) orientation arrows must be shown on each package.

RE: Changes to BX-11DF

Dear Valued Customer,

In an effort to continuously improve the quality and performance of our UN packaging, we occasionally must make changes to the specifications and usage instructions. This notice is to inform you that the following changes have been made to **BX-11DF (PK-MTM11/PK-MTM11NS)**.

1. The clear tape required for closure of this packaging has changed from 3M #305 48mm wide clear tape to 3M #375 48mm wide clear tape. This change to a stronger tape caused the box to perform better in drop tests, resulting in a more secure packaging.
